PILES OF BOOKS

There are piles of books in my house. They take up a lot of space; most I will not reread.

How does one get rid of books? There are the standard replies: pass them on to others, donate them to a charity, sell the ones in good condition, or simply toss them away.

I did a bit of internet research on what to do with no-longer wanted or needed books. While there were not many ideas different than already mentioned, the ideas were expanded. For instance: Sell the books on a site such as Half, Amazon, or eBay. Some sites will pay for old books; list the ISBN on sellbackyourbook.com for a potential list of buyers.

You can also trade your old books for new books. There are lots of sites for this: BookMooch, GreenTextbooks, PaperBackSwap or TitleTrader. Typically for every book you send to someone else you get a credit towards getting a new book.

Some places welcome book donations. Your local library might take them for a book sale. If your library does not take them, the International Book Donations Program lists institutions, organizations, town and village programs all over the world that have no other way of acquiring reading and educational materials.

A site that I use, BetterWorldBooks, donates a book to a school or organization for every one I buy through them (free shipping!). Also, BetterWorldBooks will email a shipping label to use on boxes of books you may want to donate through them. Doing a search on "book donations" will bring up countries trying to rebuild their libraries.

A fun option – release your books "into the wild" at BookCrossing. Register your book with this site and leave it somewhere so someone can find it. The idea is to track where your book goes. You could also set up a "Free Book Exchange" box or list books on one of the online free merchandise pages like Freecycle or craigslist.com.

FRA Board Members Holly Weiler and Marvin Moore have established and built a "mini-library" at the Community Center; you can donate your books here or exchange your books for new ones.

Whether you sell them or give them away, you will be putting the books to use, and making room for more in your house!

SUMMER BBQ & Root beer float

FIRE REPORT

What was feared in the spring would be a dangerous 2013 fire season turned out wonderfully quiet. For the five month period from May through the end of September, Fire Station 96 responded to only 12 incidents. Only two calls were fire related - one unauthorized burning and one smoke/odor call. There were four EMS or medical assist calls, one car accident, and one unspecified "citizen complaint." There were also four false alarms - "no incident found on arrival at dispatch address." Thanks as always to our firefighters at Station 96 for always being there for Foothills Residents!

SIGNS, SIGNS.....

Remember the song "Signs, signs, everywhere a sign...?" It was a big hit in the 70's but the lyrics are still valid today.

Recently an advertising sign appeared along Forker Road and some neighbors had negative opinions of it. It was a 4' x 8' wooden sign mounted permanently along the roadway edge.

First let me state that the purpose of the sign was to advertise a business. Nothing sinister or malicious there. The company placed the sign to increase business. Its location was due to the number of vehicles or potential customers viewing it.

There are, however, many laws regarding signs in Spokane County. First, signs must be placed in a safe location so that they do not pose a traffic hazard. Signs should not screen a view from a street or other driveway because it would make it difficult to safely enter the street. Signs at intersections must be placed outside of the "Clear View Triangle". That is the triangle formed by the corner of the intersecting streets and the eye point view of a person driving a car. If this view is obstructed, a driver would be forced to pull forward into the intersection to see - creating a danger of collision. The decision to enter or wait for traffic is compromised.

The second legal consideration is the County Sign Code. In Spokane County it is illegal to advertise "off-site" businesses. If a sign advertising a business is not directly residing on the property it advertises, it is illegal in this county, except for certain permitted billboard locations and zones.

Another legal consideration is that a sign that is permitted in certain zones must comply with set-back rules. A legal sign must comply with size requirements, clear view safety, and distances from adjacent landowners. Adjacent landowners should not have their properties' values diminished by a sign of a neighbor. That is why there are zoning rules.

The sign along Forker Road was identified to Spokane County Code Enforcement, the agency responsible for identifying and correcting code violations. Complaints must be initiated by a County resident. The complainant identifies a perceived infraction which is investigated by a Code Compliance officer. The officer determines if there is a code violation. If there is, he notifies the responsible party, which may be the landowner or a distant business. He explains to the sign owner the relevant regulations and deadlines for remediation. If the sign owner does not make the sign compliant, the county may take legal action to force compliance. Due process is afforded the sign owner, which can take many months.

We all need information signs such as speed limit, signals, and road signs, but a proliferation of unlimited off-site advertising is often very ugly to everyone but the business owner. Rules protect neighbors and provide for some level of safety.



The Foothills Rural Association, 11000 N. Forker Road, was established as a non-profit corporation under section 502(C) (4) of the Internal Revenue Code on December 12, 1983. The purposes of the corporation are to organize the property owners and/or current residents within the boundaries of Fire District 9, Station 6: to provide a forum by which the property owners and/or current residents to assist governmental agencies in better planning the use and resources of the Foothills area: to preserve and protect the rural agricultural environment.

Voting Membership in the Association is open to any property owner or current resident within the Foothills boundaries. Membership dues are \$20 per year. Non-voting Membership is available to others through payment of dues. The Association is governed by elected volunteer officers and a board of directors.

FRA Alerts system has been established in an effort to increase community awareness about crime occurring in our area. Residents are encouraged to report ALL crimes to Crime Check, 456-2233. 
