JESS KRONQUIST MEMORIAL SCHOLARSHIP

My Foothills Rural Association newsletter archives begin with Vol. 10 No. 3, October 1992. Printed in that issue is the statement: "The Blue Ribbon Circle is pleased to announce that Heather Larson was the first recipient of the Kronquist Scholarship of \$500". This was the beginning of the current practice of awarding scholarships to Foothills area residents. Jesse Kronquist's family dates back to 1881 when Jess's father, Alfred settled in the Foothills area. Before Jess died in 1989, he had designated his estate to be divided three ways between the Blue Ribbon Circle, Foothills Rural Association and the Pleasant Prairie Cemetery Association. The FRA invested the \$10,000 inheritance, into a growth fund, naming it the Kronquist Endowment Fund. Based on responses to a survey polling Foothills residences, the preferred manner to handle income generated by this fund was for college scholarships. In 1993, the Blue Ribbon Circle and FRA each offered \$500 scholarships. The two organizations later combined resources to offer the scholastic awards with one application. Through the growth of the endowment fund combined with community donations, FRA has been able to increase their yearly award amounts to \$2,500; bringing the annual total educational award fund to \$3,000. Since 1992, 63 FRA/Blue Ribbon Kronquist Memorial Scholarships have been awarded.

BIRDS OF PREY

In early January, I noticed activity from ravens on the hill above our home. I scanned the surrounding tree tops and found a Bald Eagle perched. This usually means only one thing--a dead animal. So I hiked up on the hill and flushed about 6 ravens, a few magpies, two more Bald Eagles and an immature Golden Eagle (I identified it by the central wing white markings and the



white upper half of the tail.) Near a group of 20 ft pine trees I found the half eaten carcass of a whitetail deer. Twenty five feet away in the group of trees was a flattened down area where the deer had bedded down. The confined

area where deer hair was scattered indicated that the deer was either very weak or already dead when the coyotes found it. I returned later to set up my remote sensor camera. Over the next few weeks I got photos of up to 4 Bald Eagles at a time and two Golden Eagles, one juvenile and the adult in the attached photo. In addition there were up to 2 coyotes, a Red-tailed Hawk, ravens and magpies. Also, a few deer investigated the scene... sad.. Note: Golden Eagles are fairly rare in Spokane County and are often mistaken for immature Bald Eagles. However, I usually see at least one every winter in the foothills of Mt. Spokane near our home. I have never seen one here during the summertime. This indicates to me that they probably do not nest in NE Spokane Co. and are drawn here by the activity of the Bald Eagles that feed on the winter kill.

MOUNT SPOKANE ALPINE SKI CONCESSION PROPOSED EXPANSION

Background

Mt. Spokane 2000, a non-profit board, is the current concessionaire of the Alpine ski area that is operated within the boundaries of Mount Spokane State Park. The concessionaire has been working to expand the ski area boundaries since the late 1990s. Initially, the State Parks Commission could not reach an agreement regarding the area known as the Proposed Alpine Ski Expansion Area, or PASEA. The PASEA would need to be designated as either a recreational area or a resource recreation area in order for the proposed expansion to occur. However, the PASEA meets the criteria for classification as a Natural Forest Area, and has been managed as such pending the Commission decision. What Mt. Spokane 2000 Wants

Mt. Spokane 2000 wants to develop 279 acres in the PASEA, and anticipates that the new terrain will accommodate 800 more skiers and snowboarders per day. It wants to add one new lift and seven new ski runs. In a recent email, the concessionaire stated this will allow “*Continued and improved recreational opportunities for a growing population of skiers and snowboarders. *Positive economic impacts above and beyond the \$359,711 that Mt. Spokane pays the state on average in annual rent and taxes. *New sources of revenue generated by the expansion will help offset the state’s budget shortfalls and also help fund planned improvements at Mt. Spokane. *Improved skier and rider safety and reduced risk to the Washington State Parks Department. *Increased employment opportunities above and beyond the 387 jobs Mt. Spokane already provides to the Spokane area. *Add, badly needed intermediate skiing terrain, and relief for the densely crowded “cat track” area used by all.” More information at <http://www.mtspokane.com/>

The Opposition

Members of the Save Mount Spokane Coalition, made up of the Upper Columbia River Group of the Sierra Club, The Lands Council, the Spokane Mountaineers, the Spokane Audubon Society, the Washington Wilderness Coalition, the Neighborhood Alliance of Spokane County, the Hobnailers, Inc. Hiking Club, the Eastern Environmental group of Eastern Washington University, Conservation Northwest, the Northeast Chapter of the Washington Native Plant Society, and the Washington Environmental Council, take issue with several misrepresentations put forth by Mt. Spokane 2000. Among other things, Mt. Spokane 2000 claims that the proposed chair lift is merely a reinstallation of a chair that used to be in the same

area; there was never a chair lift in this area. Mt. Spokane 2000 also states that the expansion is necessary because it currently “is utterly reliant upon south-facing slopes.” However, park maps shows “currently open and available ski terrain ranging from south and east aspects served by present Chair 1, east aspects served by Chair 2, east and southeast aspects served by Chair 3, and[...]north-to-northeast aspects currently served by chair 4.” Instead of the proposed expansion, the opposition would prefer to see Mt. Spokane 2000 focus on “Improvements needed to existing ski area – The existing ski area facility is in great need of repairs and upgrades. All buildings are in need of paint and remodeling, lift houses need to be rebuilt, the 60-year old septic system needs to be replaced; and parking and other infrastructure improvements are needed.” More information at http://www.savemtspokane.org/Open_Letter_To_Mt_Spokane_2000.html

Washington Department of Fish and Wildlife

In a letter dated January 29, 2007, the Washington Department of Fish and Wildlife stated “The native and mature forest habitat on the northern aspect of Mt. Spokane is an extremely unique forest ecosystem with a high value for wildlife and species biodiversity. Considering its size, its un-fragmented condition along with its stage of forest succession and structure, a similar forest could not be found anywhere else in Spokane County nor replicated [...] WDFW is opposed to the Potential Alpine Ski Expansion Area (PASEA) proposal due to the unavoidable and extensive impacts to wildlife habitat and wildlife species associated with such a proposed ski expansion.”

Next steps

The Parks Commission is expected to issue its determination for classification and conditional uses for the PASEA on March 31, 2011. A public comment period will begin on that date and end on May 19th. Please take a minute to send in a comment supporting designation of the north and west slopes of Mt Spokane as a Natural Forest Area. The Parks Commission will review the public comments and is expected to make its final decision at their meeting in Spokane on May 19. Public comments are valued- please send personal comments, not a form letter.

FRA MEETING & SILENT AUCTION





A HEATING CHALLENGE

Last November during the cold and snow the main furnace decided to quit on us. After the FRA Board's many thoughts and discussions, it was decided to replace the existing, no longer working furnace with the same type of unit. The board and all who used the Community Center building were very grateful to Sherrie Potter for lending her wonderful propane heater! It worked fantastically during the cold winter months, to keep the building's occupants warm and the pipes from freezing! The furnace's location in the ceiling rafters above the main area close to the kitchen, posed a problem: the rafter access door is located in the ceiling behind the display case in the room where the chairs are stored – across the room from the kitchen. To get to the furnace the repair technician had to enter the area through the dropped down ceiling; crawl up through the rafters; then walk across them 40 or so feet before reaching the furnace. Adding to the problem was the access hole being very narrow, a little over 17 inches wide and not very long. I had discussed with different heating contractors various options to best handle our situation. Proposed suggestion included placing the furnace in a different location; cutting a new large access hole in middle of the ceiling in the meeting room; a different type of heating system; cut rafters to enlarge the access hole; or locating a small enough unit to get through the current access hole to do a direct replacement. Bids were requested, Cougar Mechanical was chosen as the company to use. They were able to locate a direct replacement furnace that fit through the current opening and used the same duct work saving us a bunch of money. Cougar Mechanical did a great job and worked with the FRA board to get it done quickly so as not to interrupt the rental usage. A few modifications were needed such as running a circuit for a light by the furnace and a walkway to the furnace which will be helpful in the future should we need to access the furnace. It is nice to once again have a heating unit that is quick to heat the building and not worrying about heat during very cold weather.

BOARD MEETINGS

Board meetings are held at the Community Center building on the second Monday of the month. Meetings begin at 7pm and usually end just after 8pm All Foothills residents are welcome and encouraged to attend.

2011 Board Meeting Date(s): April 11th, May 9th, June 13th, Sept 12th, Oct 10th, Nov 14th & Dec 12th.

The Foothills Rural Association, 11000 N. Forker Road, was established as a non-profit corporation under section 502(C) (4) of the Internal Revenue Code on December 12, 1983. The purposes of the corporation are to organize the property owners and/or current residents within the boundaries of Fire District 9, Station 6: to provide a forum by which the property owners and/or current residents to assist governmental agencies in better planning the use and resources of the Foothills area: to preserve and protect the rural agricultural environment.

Voting Membership in the Association is open to any property owner or current resident within the Foothills boundaries. Membership dues are \$20 per year. Non-voting Membership is available to others through payment of dues. The Association is governed by elected volunteer officers and a board of directors.

FRA Alerts system has been established in an effort to increase community awareness about crime occurring in our area. Residents are encouraged to report ALL crimes to Crime Check, 456-2233. 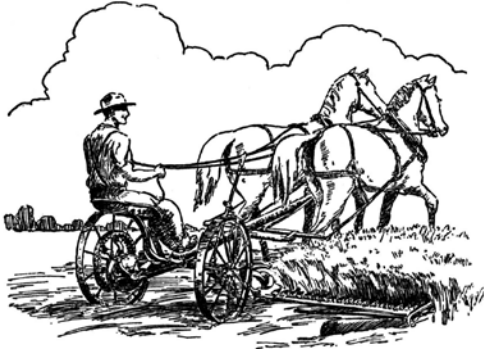

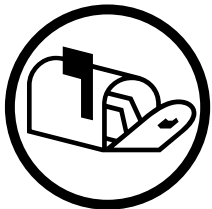
